
Introduction

The feedback survey for the National Infrastructure Assessment ran online using SurveyMonkey.com between 29 November 2018 and 11 January 2019. It was circulated to many stakeholders who had attended workshops, roundtables and events during the Assessment's development, or who submitted responses to formal consultations.


The results of the survey helped inform the report Lessons Learnt: Reviewing the process of the first National Infrastructure Assessment.

114 people responded to the survey, of which 74% completed the entire survey. Survey respondents were given the option to respond anonymously.

How did you or your organisation engage with the Commission during development of the National Infrastructure Assessment? (Multiple selections permitted)




To what extent do you agree or disagree with the following statements about the Commission's stakeholder engagement?








How have you engaged with the recommendations of the Assessment? (Multiple selections permitted)
